CALL TO ORDER

- A. Opening Ceremony

- **ROONEY** Chairman Rooney called the meeting to order. He led the Pledge of Allegiance.

- **HOFF** Chief Hoff commented on a recent fire in York City acknowledging the work YAUFR firefighters assisted with during the incident. He noted his appreciation to Comm. Gwilt for his assistance in directing traffic during the event.

- **GRUBBS** Mr. Grubbs stated the next meeting is scheduled for July 17, 2024.
- B. Personnel Committee
- **McCUNE** Ms. McCune reported she distributed the job descriptions. The committee will meet to review them.

10. APPROVAL OF MINUTES – JUNE 18, 2024 COMMISSION MEETING

MR. MILLER MOVED TO APPROVE THE MINUTES OF JUNE 18, 2024 FOR THE COMMISSION MEETING AS AMENDED. MS. McCUNE WAS SECOND. MOTION UNANIMOUSLY PASSED.

11. OLD BUSINESS

- A. Discussion: YAUFR Policies
- **HOFF** Chief Hoff indicated the YAUFR Polices are on the website.
- B. Discuss/Approve: YAUFR Commission Orientation Packet
- **HOFF** Chief Hoff stated the Orientation Packet is available on the shared Commission Documents drive. The document can be updated as necessary.
- **BISHOP** Mr. Bishop recommended having a plan to assure new commission members obtain the information.
- **HOFF** Chief Hoff stated he would be responsible for providing the document to new Commission members.
- C. Discuss: Negotiation Committee for Local 2377 Collective Bargaining Agreement
- **HOFF** Chief Hoff indicated the initial meeting with Local 2377 was held to discuss their issues and inform the union president that before the next meeting is scheduled, feedback from the Commission on the makeup of the Negotiation Committee is needed.
- **DVORYAK** Mr. Dvoryak indicated this was discussed at the Springettsbury Township Board of Supervisors and the Township Manager, Mr. Hodgkinson volunteered to be on the Negotiation Committee.

Discussion was held as to the composition of the Negotiation Team, as to whether it would be beneficial to have the manager from Spring Garden on the team as well. Chief Hoff stated for the purpose of the first meeting the Negotiation Team has been Chief Hoff, Chief Blackwell and Ms. Einsig to start the process and receive the unions issues. Chief Hoff stated updates to the process would be communicated to the Commission each month up until Arbitration would occur. A lengthy discussion was held on the feasibility of having the township managers on the Negotiation Team.

- **HOFF** Chief Hoff will provide a report of the offer/counteroffer at the next meeting.

- **HOFF** Chief Hoff stated there has been a significant response to the advertisement for the Strategic Planning RFP Plan, including out of state interests. He noted they provided information to 12-15 companies. The grant that covers part of this project needs to be closed out by early September; however, Chief Hoff will seek an extension.
